No. 61 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1981-39, EFFECTIVE JULY 20, 1981, BY TRANSFERRING THE SUM OF SEVENTY THOUSAND DOLLARS (\$70,000.00) FROM PUBLIC WORKS STREET CLEANING ITEM "0" TO PUBLIC WORKS WASTE COLLECTION AND PROCESSING ITEM "189", AS AMENDED.

*Approved* February 26, 1982

*Be it ordained by the City of Providence:*

SECTION 1. Chapter 1981-39, of the Ordinances of the City of Providence, effective July 20, 1981, entitled: "An Ordinance Making an Appropriation of One Hundred Forty-Nine Million, Eight Hundred Sixty-Two Thousand, One Hundred Twenty-Two Dollars and Nine Cents (\$149,862,122.09) as amended, is hereby further amended by transferring the sum of Seventy Thousand Dollars (\$70,000.00) from Public Works Street Cleaning Item "0" to Public Works Waste Collection and Processing Item "189".

SECTION 2. This Ordinance shall take effect upon its Passage.


Dear Mr. Baron:
