


Gentlemen:

We have investigated your request for prohibition of the use of Candace Street to vehicular traffic in excess of four tons capacity.

Consideration of a prohibition such as this must, of course, include the general pattern of traffic in the area. Candace Street is a connector street between Smith Street and Douglas Avenue and performs an important function in the servicing of cross city traffic. If trucks are prohibited from using this street, they must use other parallel streets in the area in order to reach their destination. However, Candace Street is the widest street available in this area and is, therefore, best suited for handling truck traffic.

Accordingly, we do not recommend that truck traffic be prohibited from using this street.




Gentlemen:

We have completed our investigation, which you requested, of traffic conditions at the intersection of President Avenue and Grotto Avenue.

Both of these streets carry low volumes of traffic. In addition the accident rate at this location is low. There have been only two reported accidents here in the past four years.

Therefore, we do not recommend the establishment of controls at this intersection.




We have completed our investigation of your request for a study of the possible need for traffic signals at the intersection of Laurel Hill Avenue and Plainfield Street.

The results of our study show that additional measures are needed at this location. Therefore, we are making the following changes:

1. Installation of double "Stop" signs.
2. "No Parking To Corner" areas posted on all four corners on Plainfield Street.
3. Additional crosswalk across Plainfield Street.

We will continue to observe this intersection to see if the desired results are obtained by the measures indicated above. If these measures do not produce the desired results, consideration will be given to additional control measures.
