No. 344 AN ORDINANCE IN AMENDMENT OF SECTION 3 OF CHAPTER 778 OF THE ORDINANCES APPROVED OCTOBER 16, 1953.

Approved July 2, 1954

Be it ordained by the City of Providence:

Section 1. Sec. 3 of Chapter 778 of the Ordinances entitled "An Ordinance Providing Additional Payments to Retired Employees of the City of Providence", is hereby amended to read as follows:

"Sec. 3. For the purposes of this Ordinance the retirement allowance paid to such employee under any pension plan of the City shall be deemed the retirement allowance to which such employee would have been entitled, exclusive of any additional annuity provided by the member's accumulated excess contributions, and before reduction by any unpaid loan balance or reduction on account of an elected optional form of retirement allowance."

Sec. 2. This Ordinance shall take effect upon its passage and all ordinances or parts of ordinances inconsistent herewith are hereby repealed.
