## PERSONAL EXPRESSION

**COUNCILWOMAN YOUNG requests the privilege of the floor to speak on a point of personal expression and states:**

"These last few days we have seen a lot of things in the paper about the School Board and I know that we are not voting on it tonight, I know that it is going to committee, but I am compelled at this time to just share with you a few of my remarks and my concerns. I really was disappointed and dismayed by the recent authoritarian decision of Mayor Cianci to overlook Gertrude Blakey in his appointments to the School Board. After six years, six hard years, on the Providence School Board, Gert served with compassion and determination and worked tirelessly to improve the educational resources for our students. For her, it was a mission, a mission of love. After such exemplary work the action the Mayor took was an insult, not only to Gert, but it is an insult to this entire community, particularly the African-American community. As we prepare to celebrate the birthday of Dr. Martin Luther King, Jr., we need to know that fiasco of this appointment — or not re-appointing her — is a reminder that too many minorities still face racial inequality and that the dream that Dr. King talked about is still a dream and not a reality, the equality that we are looking for. Why do I say this? If you look at the stats, 19 percent of our entire school department are white children. That is according to the latest statistics. 44 percent of our School Board are white individuals. 19 percent of the kids are white, 44 percent of the School Board are white. It is a little out of balance. Our student population of Hispanic is 47 percent. We don't have those numbers on the School Board. The African-American population is 23 percent in

our school system of kids and the Asian population is 10 percent. We have come a long way, certainly, from the days when there were no people of color on the School Board. That was during the previous administration. It is clear that we have a lot longer way to go. We haven't reached where we need to be right now in terms of the people making the decision reflecting the diversity of the school system. I want to get back to Gert Blakey. Gert is a role model to the children of that school. She currently was the only African-American female on that Board. With her gone there is a vacuum there, and she was not only a role model for African-American children, but she was a role model for all the children. She was tireless advocate for our students. The decisions she made as the Chairwoman of the School Board were not based on politics, they were based on her belief, her understanding of what was best for the children, the health, the safety and the educational needs of all of our children in the City of Providence. I believe the reason why she was not reappointed to the School Board . . . the true reason . . . and I think we heard a few hints of this in the Mayor's remarks . . . is that Gert, as the Chairwoman of the School Board, did not promote the rubber stamp mentality that the Mayor wanted her to. I repeat. She was not a rubber stamp. She did what was in the best interest of the children. She also did not guide the Board to rubber stamp all of the Superintendent's initiatives. There has to be a check and balance in every entity, and the School Board is the check and balance for the Superintendent. Whether she knows it or not, she is to report to that body. I think what Gert did was she promoted a healthy dialogue. There is nothing wrong with disagreeing, especially if you are not disagree-

able. For those of us who know Gert, she is not a disagreeable person. Healthy dialogue is what our school system needs. It is what has brought us this far. I think for her optimistic view of the School Board, which she is a very optimistic person, she had this novel idea that the School Board should act as a check and balance, as I said, and for that she became an outcast. *Persona-non-grata*, she was not wanted anymore. I think the message that is being sent to everyone right now by the Mayor, who might want to consider a position on our School Board is clear, if you are Apolitical, you will not survive. If you follow your conscience, if you try to act as a mediator between the teachers and the Superintendent, you are sealing your own fate. You will not last long on the Providence School Board if you try to believe that you are a voice for the voiceless. Gert was and is a consensus builder. I remember the days when we were bringing Diana Lam to the school system. She was the one. She was the main force behind getting her appointed and hiring her. It was through her leadership, her ability to be a consensus builder and to be able to build bridges between people that that happened. I think what she has done in these last couple of years is provide a balance to, in my opinion, a Superintendent who has often, in my opinion, created brush fires on several issues. Gert has been there with a water hose putting them out. Sometimes by herself, sometimes with a collective wisdom of the School Board, but she was always there trying to help to smooth the way. She stood behind what she believed in. She understood that school reform was not a one person concept. There must be collaboration between the teachers, the Superintendent, the School Board and the public. We see now the School Board is sometimes — when I am at the meetings — trying to get away from public input. We can never let that happen. That is a public body, the public must always be able

to speak and not be treated as if they were not worthy of being there, or as if they were part of a circus act, as I overheard one of them call it one day as a circus mentality. She understood that the running of a school is not a dictatorship, but a partnership. Yet, if you read the Providence Journal, and I know Greg that you guys wouldn't lie about what the Mayor has said, the Mayor complained that Ms. Blakey could not create cohesion on the School Board. He stated that the School Board needed a cohesive body. I suppose the Mayor knows an awful lot about cohesive bodies, since he has done such a wonderful job in helping to create a cohesive legislative body here in the City Council. And he has, hasn't he? There is no divisiveness on this Council. We all get along? We all do things the right way, don't we? Or is there? Does that make us any less effective? I think we need to look at what this woman has brought to the table all these years. I also think that the Mayor needs to look at his own shortcomings, because he has a few, if you haven't noticed them, and put his own house in order before making accusations about this woman's integrity, her competence and about her leadership. Finally, I wonder, if she was such a terrible leader, such a terrible Chairwoman, why does she receive several offers of employment, not only by the Administration, but by the Mayor himself, during her years of service on that Board. I am talking about only a few weeks ago she was asked to take another position. Do you remember Julia Steiny? Do you remember Donald Lopes? Do the names sound familiar? Do you remember Mary Smith? These are some of the people who systematically were removed by the Mayor, and these were competent, hard working people. Their fault was they challenged the status-quo. They worked too hard for the little bit of money that we gave them. I think what the Mayor is saying to you and to

everybody right now, it doesn't matter how hard you work in Providence on our Boards or Commissions, it doesn't matter how good you do your job. You can always be replaced by politics and campaign contributions. I am not surprised that this happened. Not at all. Disappointed, upset? Absolutely. But when you have a City Hall that is for sale . . . I want to repeat that . . . when you have a City Hall that is for sale, when certain Commissions and Boards and Contracts are for sale, anything can happen, and when you are dealing with individuals who individually and collectively are morally bankrupt, these types of insanity prevails. In 1993 there was a process that was established for selecting School Board members and this process wasn't recommended by the City Council. It was recommended by the Providence Blueprint for Education. A group of individuals who thought that we needed a process to determine who should be the candidates to be on the School Board. That process was bypassed once again by the Mayor. I think that two of the people never went through the process. He is not legally bound by the process, but he created it. He prepared an Executive Order. We have followed the process in the past. People need to be clear. If we are going to throw the process out the window, let's

decide now and let's do it. Let's not fool people, and the public especially, into thinking they are part of a process and they are not. People put a lot of time into that process. They volunteer a lot of time. The community comes out to be a part of that to ask the tough questions, but it doesn't make a difference in the end. I don't think we should even imply that the School Board Nominating Committee has a valid role, because they don't have a valid role if the Mayor can just discard what they say and go and pick whoever he wants and then make an appointment on a vacuum. An appointment on the basis of political goals and agenda. That is not what our kids need. With Gert we had someone people have identified with as a shining light in an otherwise very dark city. She was an individual with integrity, accountability, competence and fairness. And if she is allowed to be removed from the School Board, it will be one more cloud over this city of clouds reminding us that here everything is for sale . . . and the cost . . . I think when you start to sell things, the cost ends up being, particularly with our school system, the cost is our children's educational lives. Thank you very much."
