No. 136 **AN ORDINANCE** IN AMENDMENT OF THE APPROPRIATION ORDINANCE CHAPTER 1974-19, APPROVED JUNE 19, 1974, BY APPROPRIATING A SUM NOT TO EXCEED THREE THOUSAND (\$3,000.00) DOLLARS, TO THE MAYOR'S CONTINGENCY FUND.

Approved April 13, 1976

Be it ordained by the City of Providence:

SECTION 1. Chapter 1974-19 of the Ordinances of the City of Providence, as approved June 19, 1974 entitled: "An Ordinance making appropriation of \$3,000.00 for the period beginning July 1, 1974 and ending June 30, 1975 and further extending to Fiscal Year beginning July 1, 1975 through June 30, 1976 as amended is hereby further amended by appropriating the sum of Three Thousand (\$3,000.00) Dollars to the Mayor's Contingency Fund.

SECTION 2, The said sum of Three Thousand (\$3,000.00) Dollars as thus added and appropriated shall be obtained by authorizing the City Controller and City Treasurer to transfer Three Thousand (\$3,000.00) Dollars from the Reserve Extraordinary Expenditures Account to the Receipt Account.

SECTION 3. The estimated Receipts from the Reserve for Extraordinary Expenditures Account are hereby increased by Three Thousand (\$3,000.00) Dollars.

SECTION 4. This Ordinance shall take effect upon its passage.
