## COMMUNICATION

Communication from Councilman Joseph DeLuca, dated July 20, 1999, to the Honorable Members of the City Council relating to the City Budget.

July 20, 1999

Dear City Council Members and City Clerk:

Should we raise taxes this year or not? This is the most difficult of all decisions a councilperson has to make. Raising taxes is not like asking for a one time volunteer contribution. Raising taxes is a mandatory payment for life. That is why, before increasing an already heavy financial burden on the taxpayer, we must consider both the immediate and long-term impact it will have on the city.

The tax rate of the city is a major consideration to relocate, stay or leave the city, for both business and residential property owners. Voting for a tax increase must be done only when all other options have been exhausted. I think we have other options open to us. We can pass a fair and workable budget without raising taxes. There is plenty of fat to trim in this budget. I compared that FY 98-99

and the FY 99-00 budget, and found 3 million dollars of increase in salaries as follows:

Another interesting fact is the police and fire budgets. Police and fire will cost the city \$6,347,666 more in the fiscal year 99-00 than did fiscal year 98-99. While the estimated budget for fiscal year 00-01 call for another 8 million dollar increase, that is over 14 million to pay for an 8.7 million contract. See attached letter from Boyce Spinelli to Councilwoman Nolan. Where is the 6.2 million dollars that fiscal year 99 was supposed to have produced?

Please take the time to compare the FY98-99 budget and FY99-00 budget. Look at where the tax increase will go in view of what is already in the plate. Do they really need more?

Resolution Requesting reconsideration of Resolution Number 167, approved March 26, 1999, relating to the execution of agreement between the City of Providence, the Water Supply Board and Fleet National Bank for a one year demand note in the amount of Five Million Dollars (\$5,000,000), as amended.

*Resolved*, That His Honor, the Mayor, is hereby authorized to execute an agreement between the City of Providence, on behalf of the Providence Water Supply Board, and Fleet National Bank for a Five Million Dollar (\$5,000,000.00) term loan for a 364-day period.

The terms and conditions of the agreement and any promisory note delivered in connection therewith shall be consistent with the Board of Contract and Supply award of December 21, 1998 to Fleet National Bank, low bidder, for RFP for Short Term Borrowing up to \$5,000,000 plus interest, in an amount not to exceed 70 basis points above the floating LIBOR Rate (or greater upon the occurrence of an event of default).

*Now, therefore, be it Resolved*, That Resolution No. 167, approved March 26, 1999, relative to an agreement between the City of Providence, on behalf of the Providence Water Supply Board, and Fleet National Bank for a one year Demand Note for Five Million Dollars (\$5,000,000.00), is hereby rescinded.

## PERSONAL EXPRESSION

**COUNCILMAN JACKSON requests the privilege of the floor to speak on a point of personal expression and states:**

I would like to thank the members of the Finance Committee who helped put together this budget. It was a difficult process and all the departments cooperated with us by coming in and looking and picking apart their budgets and we have had to make some tough decisions and we know some of those decisions are not popular with everyone. Some of those decisions effecting the School Department but we have to begin to change the process and the way government works. Just adding programs and adding benefits is not the way government should work, that is not true reform. We have to look to that process and we made some difficult decisions and we have to continue to scale back on the way that government operates and again I want to thank my colleagues on the Finance Committee and I want to thank my colleagues who are not on the Finance Committee that came in and made some excellent points and two of them I will point

out. Monday night when we talked about the night time school, Councilwoman DiRuzzo brings up an excellent point. Every time that there is a new program we are not evaluating the old programs and we are never getting rid of anything and we just continue to grow and the taxpayers continue to own them and we can't allow that to happen because we represent all the taxpayers. So that is an excellent point and I agree with her wholeheartedly on that and then last night after the meeting Councilman Hassett suggested the night school. I think all the council is in favor of it but not to be tied to a teachers contract. Something that has no proven track record which is not even addressing why kids drop out of school, why does it need to be attached to a teachers contract. It needs to be a pilot program and as Councilman Hassett suggested through the help collation and then look at it, evaluate it, if it works keep it and then possibly move it into a contract and if it doesn't work lets get ride of it. Again, I thank all my colleagues.
