Managed the dispersion of \$1,000,000 in grants awarded to multi-ethnic groups representing Southeast Asians, Latinos, Native-Americans, Africans, Cape Verdeans, as well as other ethnicities to educate the community on occupant protection safety with special concentration on the following eight underserved urban communities: Central Falls, Cranston, East Providence, Newport, Pawtucket, Providence, West Warwick and Woonsocket. To manage these programs I received the proper trainings and certifications from the U.S. Department of Transportation and the National Highway Traffic Safety Administration (NHTSA) in Program Management, Financial Management, Instruction Development and other program areas. Conducted Child Passenger Safety outreach to at-risk populations; worked with community organizations and leaders to train the public on motor vehicle occupant protection; solicited applications from organizations affiliated with minorities consistent with Section 406 Safety Belt Incentive for education and outreach; worked with schools, community organizations, faith based entities, local law enforcement agencies and the RI State Police as partners to promote safety message; educated the minority community about the "Click It or Ticket Campaigns"; attended multi-cultural community events and conducted outreach to multi-ethnic groups in RI. In addition, I lead the effort to train and certified bi-or multilingual Child Passenger Safety technicians from community organizations receiving seatbelt grant funding. Created an Occupant Protection Program for Children which focused on increasing the diversity of the Child Passenger Safety venues (e.g., health departments, insurance agencies, day care centers, fire departments, etc.) Worked in conjunction with Ready to Learn Providence and the Injury Prevention Center at RI Hospital to train hundreds of Spanish-speaking Child Care Providers about seatbelt and Child Passenger Safety.

Responsible for performing liaison activities between minority and other community advocacy groups and organizations, and the Department of Human Services (DHS) relative to the availability of Services provided by the department for their constituencies. Coordinator for the Implementation of Title VI of the Civil Rights Act of 1964: Prohibition against National Origin Discrimination as It Affects Persons with Limited English Proficiency (LEP). As the Civil Rights Officer I reported directly to the director of DHS and had under my responsibility the implementation of the LEP Policy, the language assistant services plan and procedures, and the monitoring of all LEP requirements. I Supervised DHS language interpreters and translators, as well as contracted interpreters. I trained over 500 DHS employees on Civil Rights Laws and Regulations; worked with Regional Managers to make sure all staff adheres to the Civil Rights mandates. Conducted investigations of complaints alleging discrimination; coordinated the translations of all complaint forms in the most critical languages; created a LEP brochure for all employees on the LEP four-factor analysis.

Updated all "Know your Civil Rights" posters, framed and displayed them in all the DHS waiting areas. Posters were translated in six (6) main languages according to the population served and the Census 2010 data on language spoken at home, also made possible that all notices were translated in those and made it visible to all visitors; Disseminated "I Speak Card" in all regional offices; provided guidance to the Child Care Office on the title III to make sure all child care centers, like other public assistance institution comply with the title III of the American with Disabilities Act (ADA). Worked with the Office of Rehabilitation Services to ensure all people with disabilities were treated fairly by DHS staff. Worked with field supervisors to make certain the staff were using the language line to provide over the phone assistant to LEP callers; worked with DHS legal staff to ensure that sub-recipients, contractors and vendors receiving federal and state funding were in compliance with Civil Rights obligations; Worked with the US Department of Health & Human Services/Office for Civil Rights to get technical assistance for staff about Civil Rights and Regulations.
