WHEREAS, the United States Department of Labor as the Federal Grantor Agency for the Comprehensive Employment and Training Act Program of 1973, as amended, requires that all Prime Sponsors which intend to sponsor a 1975 Summer Program for economically disadvantaged youths funded under Title III, Section 304 (a) (3) of the Comprehensive Employment and Training Act of 1973, as amended file a pre-application for federal financial assistance by May 30, 1975 and a subsequent application for federal financial assistance by June 11, 1975 for the program period commencing on or about June 15, 1975, through October 1, 1975, and

WHEREAS, the United States Department of Labor requires that the filing of said pre-application for federal financial assistance be duly authorized by the prime sponsor's governing body, and

WHEREAS, the United States Department of Labor requires that the local governing body, authorize the filing of the subsequent application, including all understandings and assurances contained therein, and directs and authorizes the Mayor of the City of Providence as the official representative of the prime sponsor to act in connection with the application and to provide such additional information as may be required.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PROVIDENCE, COUNTY OF PROVIDENCE, STATE OF RHODE ISLAND, that

SECTION 1. The City Council of the City of Providence, County of Providence, State of Rhode Island, herewith authorizes the City of Providence through its' official representative, the Mayor, to file a pre-application for federal financial assistance to the United States Department of Labor and a subsequent application for federal financial assistance for the purpose of obtaining federal financial assistance to fund a 1975 Summer Program for economically disadvantaged youths as authorized and funded by Title III, Section 304 (a) (3) of the Comprehensive Employment and Training Act of 1973, as amended and to do all things necessary in connection therewith and to furnish such additional information as may be required.
