

# RESOLUTION OF THE CITY COUNCIL

No. 364

*Approved* August 15, 1989

WHEREAS, Two vacancies exist in the Office of the City Council one from the First Ward in the City of Providence, Rhode Island caused by the resignation on August 10, 1989 of Carolyn F. Brassil, one from the Seventh Ward in the City of Providence, Rhode Island caused by the resignation on August 10, 1989 of Louis R. Stravato and,

WHEREAS, in accordance with the provisions of Section 206(b) of the City of Providence, Rhode Island Home Rule Charter of 1980, it is mandatory that a Special Election for the purpose of filling said vacancies be held within ninety (90) days of the occurrence of such vacancies; and

WHEREAS, Section 17-15-4 of the General Laws of the State of Rhode Island provides a primary election for the nomination of such city or town officials shall be held and the local board shall fix the date thereof; provided, however, that said primary election shall have been held by the thirtieth (30th) day preceeding the date fixed for said election.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Providence, Rhode Island, that in compliance with the provisions of the governing charter provision and statutes, the said City Council does hereby order a Special Election to be held for the purpose of filling the vacancies in the Office of City Councilwoman from the First Ward of the City of Providence, Rhode Island, caused by the resignation on August 10, 1989 of Carolyn F. Brassil and the vacancy in the Office of City Councilman from the Seventh Ward of the City of Providence, Rhode Island, caused by the resignation on August 10, 1989, of Louis R. Stravato, and

BE IT FURTHER RESOLVED, that the Board of Canvassers and Registration of the City of Providence, Rhode Island, and all other officers whose duty is is to prepare for elections, are hereby requested and notified to make such preparations for said elections as required by law, and

BE IT FURTHER RESOLVED, that the City Clerk is directed to cause a certified copy of this Resolution to be transmitted to the Board of Canvassers of the City of Providence, Rhode Island; and that a duly certified copy of this Resolution be transmitted to the State of Rhode Island Board of Elections and to the Secretary of State of Rhode Island.
