


RESOLUTION OF THE CITY COUNCIL


Approved October 29, 2001

This letter is in regards to the original Resolution to block off Gulf Road from Loring Avenue and a portion of River Road at Irving Avenue for a one-year period.

Lieutenant Timothy Lee, Commanding Officer, Traffic Bureau, spoke to Councilwoman Williams and advised her he has no problem with the proposal. 
Dear Councilman Clarkin:

Providence Gas owns and maintains a gas main within the proposed block off area. We own and maintain a 16" gas line which crosses the Providence River via Gulf Road. We will require access to this road twenty-four hours a day seven days a week to maintain these facilities. If this road is blocked via a gate we will require a key to enter. This line is the major feeder line between East Providence and Providence.
