AN ORDINANCE AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1983-30, APPROVED JULY 10, 1983, BY TRANSFERRING CERTAIN SUMS OF MONEY WITHIN THE DEPARTMENT OF PUBLIC SCHOOLS.

Be it ordained by the City of Providence:

SECTION 1. Chapter 1983-30, of the Ordinances of the City of Providence approved July 10, 1983, entitled: "An Ordinance making an Appropriation of One Hundred Sixty-Nine Million, Seven Hundred Ninety-Six Thousand Two Hundred Forty Dollars and Ninety Six Cents (\$169,796,240.96) as amended", is hereby further amended by transferring certain sums of money within the Department of Public Schools as follows:
