## ORDINANCES SECOND READING

The following Ordinances were in City Council January 16, 1986, Read and Passed the First Time, and are Returned for Passage the Second Time:

An Ordinance in Amendment of and in Addition to Sec. 1-10 (a) of Chapter 1 of the Code of Ordinances of the City of Providence, Entitled: "General Penalty: Continuing Violations".

*Be it ordained by the City of Providence:*

*Section 1.* Sec. 1-10 of Chapter 1 of the Code of Ordinances of the City of Providence, entitled: "General penalty: continuing violations", is hereby amended by deleting sub-section (a) in its entirety and adding the following in lieu thereof:

"(a) Whenever in this Code or in any ordinance or resolution of the city any act is prohibited or is made or declared to be unlawful or an offense, or whenever in such Code, ordinance or resolution the doing of any act is required or the failure to do any act is declared to be unlawful or an offense, where no specific penalty is provided therefor, the violation of any such provision of this Code of any such ordinance or resolution shall be punished by a fine of not less than one dollar (\$1.00) nor more than five hundred dollars (\$500.00), or by imprisonment of not less than one (1) day nor more than thirty (30) days and/or require restitution in cases involving property damage or personal injury in an amount up to twenty-five hundred dollars (\$2,500.00) and/or for voluntary community service for a town or city agency for not more than ten (10) days for any one (1) offense, unless other penalties therefor, or penalties within other limits, are specially prescribed by statute, to be prosecuted by some office appointed for that purpose, and to be recovered to the use of the city, or of such person or persons, and in such proportions, as said ordinances or regulations shall designate. Each day any violation of this

Code or of any such ordinance or resolution shall continue shall constitute a separate offense."

*Section 2.* This Ordinance shall take effect upon its Passage.

An Ordinance in Amendment of and in Addition to Sec. 4-4 of Chapter 4 of the Code of Ordinances of the City of Providence, Entitled: "Animal or Fowl".

*Be it ordained by the City of Providence:*

*Section 1.* Chapter 4 of the Code of Ordinances is hereby amended by deleting Sec. 4-4 and inserting in lieu thereof:

"Sec. 4-4. Keeping fowl. No owner or occupant of any dwelling house shall keep or permit to be kept, any live fowl, geese, ducks or pigeons in any dwelling house or in the cellar of any such house, nor shall any such fowl or pigeons be kept within the city limits."

*Section 2.* This Ordinance shall take effect upon its passage.

An Ordinance in Amendment of and in Addition to Article III of Chapter 17 of the Code of Ordinances of the City of Providence, Entitled: "Officers and Employees".

*Be it ordained by the City of Providence:*

*Section 1.* Chapter 17 of the Code of Ordinances of the City of Providence, entitled: "Officers and Employees" is hereby amended by adding to Article III thereof, the following:

*Sec. 17-125.* Buy back of time for pension purposes.

No City employee shall be allowed to buy back time for pension purposes without the express approval of the City Council.

*Section 2.* This Ordinance shall take effect upon its passage.

An Ordinance Repealing Sections 25-50 through 25-63 of Article IV, inclusive, of the Code of Ordinances of the City of Providence, Entitled: "Sewer Charges".

*Whereas,* Secs. 25-50 through 25-63 of Article IV, inclusive, of the Code of Ordinances of the City of Providence, concerns sewer charges to be charged by the City of Providence, and

*Whereas,* The City of Providence in the future will no longer assess sewer charges as a result of said contract, with the Narragansett Bay Water Quality Management District Commission

*Now, therefore, be it Ordained by the City of Providence:*

*Section 1.* Sections 25-50 through 25-63, inclusive, of Article IV of the Code of Ordinances of the City of Providence are hereby repealed, effective July 1, 1985.

*Section 2.* This Ordinance shall take effect upon its passage.
