Associate Director of Administration for Planning, Rhode Island Division of Planning and Statewide Planning Program, July 1968 to June 1995. Directed the planning staff in formulating goals and policies for the future development of the state, preparing and maintaining strategic plans and the State Guide Plan, coordinating the activities of governmental agencies and private interests within this framework of policies and plans, and providing planning services to the Governor, the General Assembly, and state agencies. Also supervised assistance to local governments in management, finance, and planning, and administered several state aid and tax programs. The Associate Director also serves as Secretary of the State Planning Council.

Advisor, Hawaii Government Organization Committee, 1976. Assisted this committee in restructuring the executive branch and management functions of state government.

Project Director, National Land Use Task Force, Council of State Governments, February to July 1974. This assignment was undertaken while on six months' leave of absence. 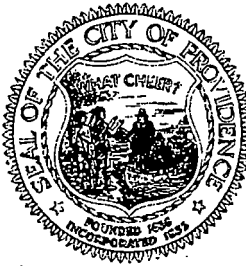
