*Be it ordained by the City of Providence:*

SECTION 1: Chapter 666 of the Ordinances of the City of Providence as approved September 22, 1952, and entitled: "An Ordinance Making Appropriation of \$28,328,060.70 for the Support of the City Government for the Fiscal Year Ending September 30, 1953", as amended, is hereby further amended by adding the sum of Fifteen Thousand (\$15,000) Dollars to the appropriation contained therein for GRANTS-TO-OUTSIDE-AGENCIES AND INSTITUTIONS-PROVIDENCE PUBLIC LIBRARY.

SECTION 2: The said sum of Fifteen Thousand (\$15,000) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and the City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3: The Estimated Receipts from Reserve for Extraordinary Expenditures is hereby increased by Fifteen Thousand (\$15,000) Dollars.

SECTION 4: This Ordinance shall take effect upon its passage.
