Honorable Gentlemen:

The City Council Resolution of June 2, 1960, requesting the Commissioner of Public Safety to study the warranting of employing women Parking Checkers on a 48 hour weekly basis, was referred to the Chief of Police.

After consultation and study by the staff of the Traffic Bureau it was determined that the employment of women checkers for 48 hours is not feasible and also not required. The Chief concurred in this finding.

I am in agreement with the Chief and his staff that a 48 hour work period for these women is not indicated by present conditions.



However, the accident record and relatively light volume at this location do not warrant the establishment of "Stop" control at this time.


