## CHAPTER 1576

No. 596 AN ORDINANCE ESTABLISHING BUS LANES ON  
PORTIONS OF WASHINGTON, EMPIRE AND WEYBOSSET STREETS.

Approved October 18, 1963

*Be it ordained by the City of Providence:*

SECTION 1. The City Council of the City of Providence, acting under authority of subsection (f), Section 2 of Article III of Chapter 176 of the Public Laws of Rhode Island, 1962, entitled "An Act Authorizing the Conversion of Certain Streets of the City of Providence into Pedestrian Malls, " approved April 20, 1963, hereby determines that in order for the flow of vehicular traffic and in particular intra state busses to be efficient and not cause unnecessary traffic congestion within the downtown area and in particular Washington, Empire and Weybosset Streets, that there be established during certain hours bus lanes for the exclusive use of the intra state busses serving the City of Providence.

SEC. 2. There is hereby established on that portion of Washington Street, beginning at the intersection of Eddy Street and running to the intersection of Empire Street on the right hand side, a lane not less than ten (10') feet wide nor more than twelve (12') feet wide measured from the curb line of said Washington Street, which shall be for the exclusive use of intra state busses and vehicles making right turns during the periods from 7:00 A. M. to 10:00 A.M., inclusive and from 1:00 P.M. to 10:00 P. M., inclusive, on weekdays.

SEC. 3. There is hereby established on that portion of Weybosset Street, beginning at the intersection of Empire Street and running to the intersection of Eddy Street on the right hand side, a lane not less than ten (10') feet wide nor more than twelve (12') feet wide measured from the curb line of said Weybosset Street, which shall be for the exclusive use of intra state busses and vehicles making right turns during the periods from 7:00 A. M. to 10:00 A. M., inclusive, and

from 1:00 P. M. to 10.00 P. M., inclusive, on weekdays.

SEC. 4. There is hereby established on that portion of Empire Street, beginning at the intersection of Washington Street and running to the intersection of Weybosset and Broad Streets on the right hand side, a lane not less than ten (10') feet wide nor more than twelve (12') feet wide measured from the curb line of said Empire Street, which shall be for the exclusive use of intra state busses and vehicles making right turns during the periods from 7:00 A. M. to 10:00 A.M., inclusive, and from 1:00 P. M. to 10:00 P.M., inclusive, on weekdays.

SEC. 5. The Traffic Engineer of the City of Providence is hereby directed to appropriately mark by erected signs, pavement markings, and/or other means those bus lanes established by this ordinance.

SEC. 6. Any person violating the regulations established by this ordinance shall be subject to a fine or imprisonment as prescribed in Chapter 1, Section 10 of the Revised Ordinances of the City of Providence, 1946, as amended.

SEC. 7. Any vehicle either parked or left standing in violation of the regulations established by this ordinance, may be towed away by any authorized towing agency at the expense of the owner. Fees chargeable to be the same as set forth in Chapter 1443, Section 1 of the 1961 Ordinances of the City of Providence.

SEC. 8. This ordinance shall take effect at such time as the Traffic Engineer shall certify to the City Council that the operation of such bus lanes are necessary, and all ordinances and existing traffic regulations inconsistent herewith are hereby repealed.

RESOLUTION OF GOVERNING BODY OF APPLICANT

Resolution providing for increase in planned total expenditure for capital improvement projects.

Whereas, under the terms of Public Law 87-658, approved September 14, 1962, the United States of America has authorized the making of a grant to aid in financing the construction of a specific public works project, provided the proposed or planned total expenditure of the public body for its capital improvement projects is increased by an amount approximately equal to the non-Federal funds required to complete such public works project:

Now, Therefore, Be It Resolved By The City Council of Providence, Rhode Island

Governing Board of Applicant

1. That as of the date of filing of an application by City of Providence

(Exact Legal Corporate Name of Applicant)

(hereafter called Applicant) with the Housing and Home Finance Agency, United States Government, for a grant to aid in financing the construction of Sanitary & storm sewer facilities; new water main and pedestrian shopping mall (Brief Project Description)  
the Applicant had a capital improvements plan or capital improvement budget for the fiscal year or years during which construction of the proposed project is expected to occur; and that the total expenditure for capital improvements in said plan or budget was \$ \_\_\_\_\_ for the fiscal year ending \_\_\_\_\_ and \$ 4,069,129 for the fiscal year ending 9/30/64.

2. That, in the event that said Federal grant is approved by the United States of America, said capital improvements plan or capital budget will be is hereby increased by \$ \_\_\_\_\_ for the fiscal year ending \_\_\_\_\_ and \$ 172,500 for the fiscal year ending 9/30/64 for a total increase of \$ 172,500 in the proposed or planned total expenditure for capital improvement projects (exclusive of Federal funds).

3. That said total increase in the proposed or planned total expenditure for capital improvement projects is approximately equal to the non-Federal funds required to complete the public works project for which the application is to be submitted.

This resolution is adopted pursuant to the authority provided by Chapter 832, Public Laws of Rhode Island, 1940, Sec. 25 & 26 - Charter of the (cite applicable State or City of Providence. local law).

Resolution 316, approved April 19, 1963 is hereby rescinded.
