EASEMENT CITY OF CRANSTON TO CITY OF PROVIDENCE

KNOW ALL MEN BY THESE PRESENTS, THAT

The City of Cranston, a municipal corporation in the State of Rhode Island, for consideration paid, does hereby, by and through its Mayor thereunto duly authorized, grant to the City of Providence, a municipal corporation in the State of Rhode Island, its successors and assigns, an easement, perpetual in duration, granting it the right to lay, locate, build, operate, maintain, repair, construct and renew a process of 16 inch water main and appurtenances in that certain parcel of land in the City of Cranston now or lately owned by Atlantic Tubing & Rubber Company, a Rhode Island corporation, and in which said City of Cranston possesses a perpetual easement to lay, construct, repair, maintain, renew, etc., a sewer line and sewer service, said parcel of land being described as follows:

A strip of land located in the City of Cranston, 25 feet wide bounded and described as follows: Beginning at a point in the easterly line of the extension of Park View Boulevard 25 feet southerly from the southerly boundary of the right of way of the United Electric Railways Company, which right of way is hereinafter referred to as said railroad; thence southeasterly along an arc about 977.69 feet to a cylindrical concrete bound (C) in the westerly line of the extension of Mill Street; thence in a northeasterly direction along the westerly line of the extension of Mill Street to the southerly boundary line of said railroad; thence in a northwesterly direction along the southerly boundary line of said railroad to its intersection with the easterly line of the extension of Park View Boulevard; thence in a southerly direction along the easterly line of the extension of Park View Boulevard 25 feet to the point of beginning, being a part of Tract Two taken by the City of Cranston by eminent domain pursuant to the provisions of an Act of the General Assembly of the State of Rhode Island at its January Session AD 1939 for sewer purposes in perpetual right and easement.

Together with the right of the City of Providence its servants, agents, officers, employees, to enter at all reasonable times upon said land with its tools, trucks, motor vehicles and other appliances as may be necessary to build, rebuild, lay, operate, maintain, repair, inspect or renew said water main and appurtenances; the location of said water main and appurtenances in the area of land described aforesaid to be as shown on the plan attached hereto and made a part hereof by reference prepared by the Water Supply Board of the City of Providence and entitled "City of Providence Water Supply Board Easement for 16 inch water main between Park View Boulevard and Mill Street in Cranston, Drawn. E.B. Traced . Checked W.I.M. Scale 1"=100'. Date 7/6/66. Acc. 6754. Approved Philip J. Holton, Jr. Chief Engineer."

And the City of Providence covenants with the Grantor, in consideration of the aforesaid grant of easement and its acceptance thereof:

1. That all construction performed in connection with the laying of the aforesaid water main will be carried out in accordance with good engineering practice.
2. That all work shall be performed at no expense to the City of Cranston.
3. That the City of Providence will save the City of Cranston harmless from all claims that may arise in connection with the construction, maintenance, and repair of said water main.

4. That all property along the route of said water main will be left in a condition equal or superior to the condition existing prior to construction.

5. That complete plans and specifications shall be submitted for final approval prior to the start of construction to the Director of Public Works of the City of Cranston.

6. That a satisfactory inspection of construction will be worked out between the City of Cranston and the City of Providence through the officers of said Cities thereunto duly authorized.

EASEMENT GRANTING THE RIGHT TO USE AND MAINTAIN AN
EXISTING DRAINPIPE OVER LAND OF CITY OF PROVIDENCE

City of Providence, a municipal corporation in the State of Rhode Island, for consideration paid, does hereby, by and through its mayor thereunto duly authorized, grant to Gilbert J. Cloosterman and wife, Helena J. Cloosterman, of the Town of Scituate, County of Providence in the State of Rhode Island, their heirs, executors, administrators and assigns, as they are the owners of Lot No. 73 as shown on Tax Assessor's Plat No. 2 in the Town of Scituate, same also being described as Parcel No. 1531 on that certain plat plan filed in the Land Records of the Town of Scituate by the City of Providence on December 16, 1965 in connection with condemnation proceedings taken by the City of Providence for the purpose of acquiring an easement in said parcel of land, an easement, perpetual in duration, granting them the right to continue to use and maintain an existing drainpipe discharging into a nearby brook over that portion of Lot No. 82 as shown on Tax Assessor's Plat No. 2 in the Town of Scituate, said lot having been recently acquired by the City of Providence through the aforesaid condemnation proceedings as of December 16, 1965, in the area thereof hereinafter described:

A certain parcel or tract of land located in the Town of Scituate, County of Providence and State of Rhode Island, described as follows:

Beginning at a point, said point being the northwest corner of Lot No. 82 as shown on Assessor's Plat No. 2, Town of Scituate; thence south eight (8°) degrees, forty ($40'_{+}$) minutes west, more or less, along the westerly line of said Lot No. 82 a distance of ten ($10'_{+}$) feet, more or less, to a point; thence south seventy-nine (79°) degrees, fifty ($50'_{+}$) minutes east, more or less, a distance of one hundred forty ($140'_{+}$) feet, more or less, to a point; thence north six (6°) degrees, twenty ($20'_{+}$) minutes west, more or less, along the easterly line of said Lot No. 82 a distance of ten ($10'_{+}$) feet, more or less, to a point, said point being the northeast corner of said Lot No. 82; thence north seventy-nine (79°) degrees, fifty ($50'_{+}$)

minutes west, more or less, along the northerly line of said Lot No. 82 a distance of one hundred thirty-nine (139' \pm) feet, more or less, to the point of beginning.

Said parcel herein described being a portion of Lot No. 82 as shown on Assessor's Plat No. 2 in the Town of Slatuato and containing 0.03 acre, more or less, and is also shown on that certain plan or drawing attached hereto and made a part hereof by reference, same being City of Providence Drawing Acc. 6753 entitled "Easement For Existing Drain Pipe Adjacent To Supplementary Tunnel & Aqueduct", dated July 7, 1966, prepared under the direction of Philip J. Holton, Jr., Chief Engineer of the Water Supply Board of the City of Providence.

Reserving, however, to the City of Providence, its servants, agents, officers and employees, the right, at all reasonable times, to enter upon said land hereinbefore described with its tools, vehicles and other appliances as may be necessary to lay, operate, maintain, inspect and renew the supplementary tunnel and aqueduct located or to be located adjacent thereto.


Dear Mr. Vespia:

I am enclosing Resolution to the Providence City Council together with an easement proposed to be given to Gilbert J. and Helena Closterman for the purpose of maintaining an existing drain pipe discharging into a nearby brook and underdraining the foundation of their residence on Lot No. 73.

Lot No. 82, which is identified on our Condemnation Map as Parcel No. 1532, was acquired by the City of Providence in fee simple from Wesley H. and Hazel A. Patnode. In the adjoining Lot No. 73 belonging to Gilbert J. and Helena Closterman, an easement was taken at the same time for the construction of the Supplemental Tunnel and Aqueduct. At the time of the taking, there existed the drain pipe passing through property acquired in fee simple by the City which the Clostermans are requesting be maintained under easement provisions.

We would appreciate this being presented to the Council at their meeting on Tuesday, August 16.

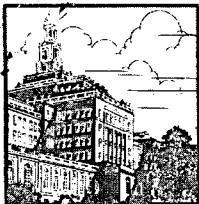

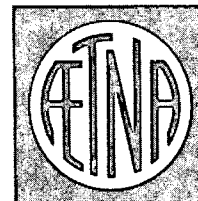


