RESOLVED,

That the City Treasurer may give notification in writing addressed to the owner of Lot No. 646 on plat No. 48 located on Prairie Ave. made for the use of the City Assessor on December 31, 1973, said lot having been sold to the City Of Providence at tax sale held May 20, 1976 and to the owner of Lot No. 523, located on Miner St., made for the use of the City Assessor as said lot appeared in the office of said City Assessor on December 31, 1957, said lot having been sold to the City of Providence at tax sale held May 19, 1960, said notices in writing addressed to the owners of record at the times of the sales, their heirs, assigns or devisees at their last usual places of abode, and notifying them that said real estate will be offered for sale unless redeemed within thirty days of said notification.
