Dept. - Engineering Office, City Property Section, Plan No. 061386, Date February 23, 1956" has ceased to be useful to the public and the same is abandoned as a public highway and the damages to the abutters is appraised at nothing and so awarded and it is further

ORDERED, that the Superintendent of Street Signs and Numbers be and he is hereby directed to cause a sign to be placed at said Salem Street abandoned as aforesaid having thereon the words "Not a Public Highway", and it is further

ORDERED, that after the entry of this order or decree the City Clerk shall cause a notice to be published in a newspaper published in the County of Providence, at least once each week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting upon said Salem Street, which has been abandoned, who is known to reside within this State.

TO THE HONORABLE CITY COUNCIL OF THE CITY OF PROVIDENCE:

The undersigned respectfully petitions your honorable body ~~xxx~~

that the portion of the following street be abandoned by the City of Providence:

That portion of Salem Street beginning at the northerly line of Waldo Street and extending northerly approximately 115 feet to the end of Salem Street.

The undersigned would point out that:

(1) the undersigned is the record owner of lots #794, #796 and #797 on Tax Assessor's Plat #43, the only lots, at ground level, abutting on the portion of Salem Street above referred to;

(2) the portion of Salem Street above referred to, is a cul-de-sac, or dead end street, so called;

(3) there is a drop of approximately 65 inches from the ground level of lots #853 and #854, which abut on the northerly side of Salem Street, to the ground level of Salem Street; and

(4) for a great many years there has been a concrete wall of some five feet in height separating the rear of lots #853 and #854, from the northerly end of Salem Street.



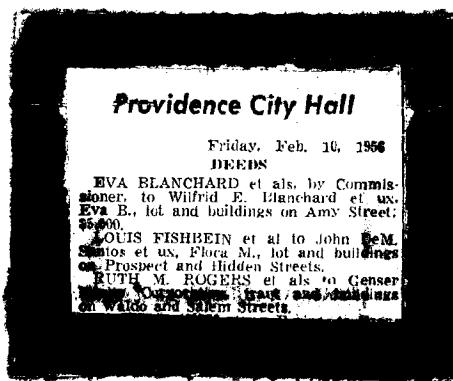

This referral is a request for the abandonment of that portion of Salem Street beginning at the northerly line of Waldo Street and extending northerly approximately 115 feet to the end of Salem Street.

On the field trip it was found that the aforementioned portion of Salem Street extends between two manufacturing plants. The area either side of Salem Street is used for off-street parking.

Due to the nature of the topography in this area it is unlikely that Salem Street will be extended to Linwood Avenue. Therefore,



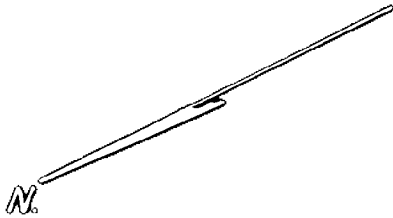

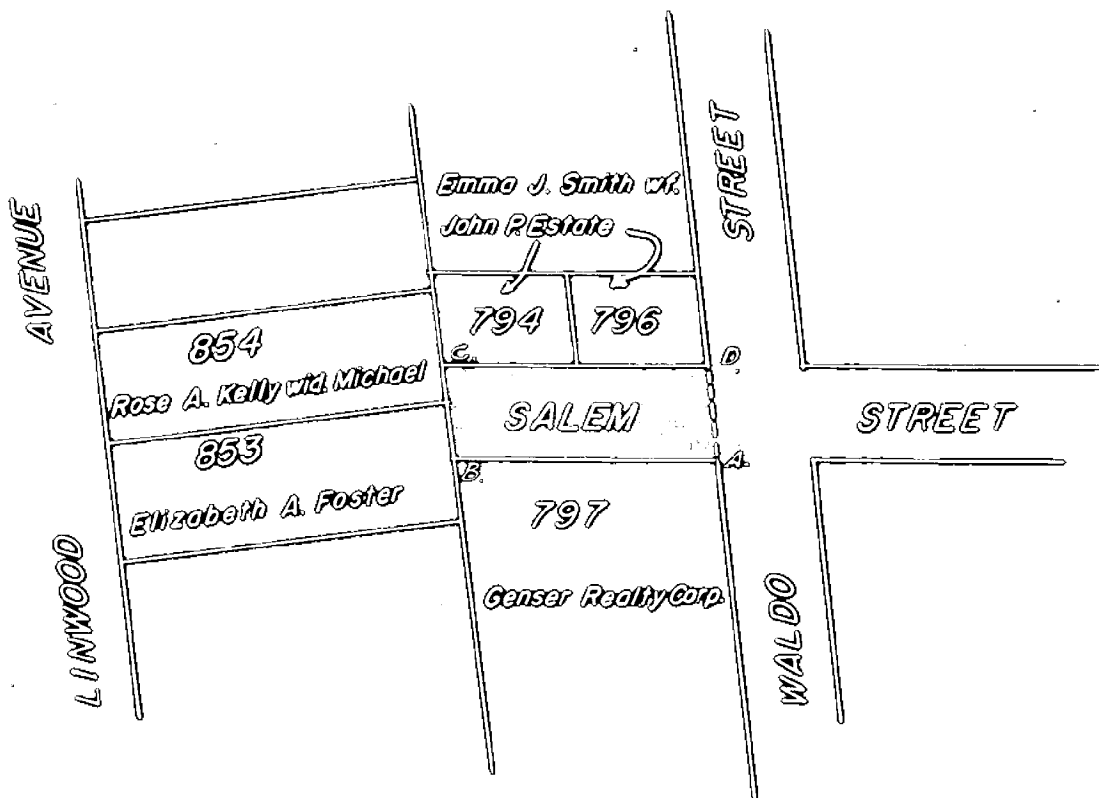

the following named person, firm or corporation is hereby granted permission to erect, alter or use a building or structure at the location named herein for the sale of petroleum, kerosene, gasoline, coal oil and their products, compounds and components as described and shown in and on the application therefor and accompanying plat, all on file in the office of the Inspector of Buildings subject to the conditions that said person, firm or corporation shall not violate any of the laws of the State of Rhode Island or any of the Ordinances of the City of Providence relative to the erection, use or occupation of said structure and that said person, firm or corporation shall not allow petroleum, kerosene, gasoline, coal oil or their products, compounds or components, to be conveyed over or across any sidewalk by means of any pipe or hose, and upon such special conditions as are hereby enumerated, viz:

WARD 3 - Application of J. Benjamin Nevin, 775 Blackstone Boulevard, - Plat 92 - Lot 150, remove 1 - 1,000, 2 - 2,000 and 1 - 3,000 gallon Gasoline Storage Tanks and replace with 1 - 5,000 and 1 - 4,000 gallon Gasoline Storage Tanks, making a total of 9,000 gallons Storage capacity upon the premises.

The erection or location of any buildings or structures not shown on the original plat on file with the Inspector of Buildings or any change in the location of buildings or structures from that shown on said plat shall be deemed a violation of this permit.

That this Minute on the Life and Character of the late Alexander Addeo, Inspector of Buildings from 1932 to 1956, be and the same is hereby adopted and ordered inscribed on the records of the City Council.

MINUTE.

Alexander Addeo was born in the City of Providence on June 6, 1899, the son of Nunzio and Celeste (Ricci) Addeo.

He was awarded a Bachelor of Science Degree by Brown University in 1920, and following that formal education, was engaged in the practice of his profession prior to being associated with the City of Providence.

Mr. Addeo's public service as head of one of the most important Departments of this City Government, saw many revolutionary changes in methods of construction and types of materials employed.

In 1941 the City Council created a Building Code Revision Committee charged with the responsibility of compiling a new Building Code, the first since the original authority of 1926.

To this Committee, composed of many distinguished and learned associates, Mr. Addeo gave vast technical knowledge, gained by scholastic training and practical experience, eminently qualifying him as its Consultant, and which, in the opinion of those who have had the responsibility of its compilation and study, claim it a fitting Memorial to his zealous and untiring efforts, spanning a period of ten years.

Mr. Addeo's reasoning and ability in his particular field of endeavor, gained for him the reputation of being understanding, concise and fair in his rulings. On the National level, he enjoyed membership on the Committee of American Standard Building Code Requirements for Masonry, for the Bureau of Standards which are published by the United States Department of Commerce.

His membership in the various engineering societies and in the organizations of his particular religious Faith, exemplified the




