**AN ORDINANCE** AMENDING THE APPROPRIATION  
ORDINANCE CHAPTER 1981-39, EFFECTIVE JULY 20, 1981,  
BY TRANSFERRING THE SUM OF TWO-HUNDRED SEVENTEEN  
THOUSAND (\$217,000.00) DOLLARS WITHIN THE PUBLIC


