

# RESOLUTION OF THE CITY COUNCIL

Approved January 4, 1991


RESOLVED, that His Honor the Mayor, is hereby authorized to execute a Lease of Lot 283 on City Assessor's Plat 56, located along Terminal Road in the City of Providence, said lot to be leased to a joint venture of Enviro-Gro Technologies, a Maryland Corporation whose principal office is in the City of Baltimore, and Narragansett Organic Recycling Corporation, a corporation licensed and registered to do business in the State of Rhode Island, with its principal office in the City of Providence for the sum of \$152,265.42 per year for a fifteen (15) year period with options to renew for two (2) additional five (5) year terms with rental to be negotiated at that time and with other terms and conditions as have been imposed by the Port Commission, the Committee on City Property, the City Council, the City Solicitor and His Honor, the Mayor.
