The Clerk counts those Standing and Voting for LOUIS J. COSENTINO, ESQUIRE, being two in number.

COUNCIL PRESIDENT HAXTON thereupon declares SANFORD H. GORODETSKY, ESQUIRE, duly elected as Chief Judge of the Providence Municipal Court for the ensuing term of Two Years ending on the First Monday in January, 1975.
