Approved March 11, 1969

RESOLVED, That the City Treasurer and the City Controller are hereby authorized and directed to transfer the sum of Twenty Five Thousand (\$25,000) Dollars from the "Trust and Special" account of the City of Providence, entitled, "Emergency Public Improvement Fund #5-580" to the Capital Fund of the City of Providence.

Of the above sum Fifteen Thousand (\$15,000) Dollars would be used to establish an account in the Capital Fund to be known as "Traffic Department Repairs and Moving Expenses Account".

The balance of Ten Thousand (\$10,000) Dollars would be used to establish an account in the Capital Fund to be known as "Recreation Department Repairs and Moving Expenses Account".

These expenditures are made necessary by the removal of the two departments to their present locations.

Said sums or so much thereof as may be necessary shall be expended from these accounts and any balance remaining after completion of said work shall revert to the "Trust and Special" account of the City of Providence, entitled, "Emergency Public Improvement Fund, #5-580.
