M I N U T E

Luigi DePasquale was born in Providence, December 13, 1892 son of the late Antonio and of Maria (Vitale) DePasquale.

Following his graduation from Boston University at the age of twenty, he was admitted to the practice of law in this State on November 9, 1914. His political life started when he was elected as a member of the General Assembly from the then 14th. Assembly District of the City of Providence. During the next eight years of his colorful life, he served the political party of his choice, as Treasurer of the State Democratic Committee and subsequently as State Chairman.

Following service as a State Senator, he was appointed to the Sixth District Court in 1935. From that time until his passing, Judge DePasquale's name was synonymous with this court of the State of Rhode Island having jurisdiction over the largest Judicial District geographically and in population. As a Jurist he was an individualist, his justice was tempered, when necessary, with laymans' understanding while his legalistic rulings, often, were cited by the members of the legal profession.

Judge DePasquale's contributions to local and foreign charities and for the cause of tolerance have been established as a monument to his memory. The State of Rhode Island, in general, and the community of Federal Hill in particular gained stature as a result of his civic endeavors. His loss is lamented while his deeds are proclaimed.

In sincere appreciation and acknowledgment of a full Christian, Charitable and Civic Life; his Honor Mayor Walter H. Reynolds and the members of the City Council join in tribute to the memory of the late Judge Luigi DePasquale and extend to his family their sympathy in his demise and consolation in his accomplishments.
