## CHAPTER 1981-23

No. 284 **AN ORDINANCE** IN AMENDMENT OF CHAPTER 12, ARTICLE III, OF THE CODE OF ORDINANCES OF THE CITY OF PROVIDENCE ENTITLED "GARBAGE, TRASH AND REFUSE" BY CERTAIN AMENDMENTS TO SECTION 12-64, AS AMENDED.

Approved May 15, 1981

*Be it ordained by the City of Providence:*

SECTION 1. Article III, Section 12-64, of the Code of Ordinances of the City of Providence entitled "Frequency of Removal of Waste" is hereby amended to read as follows:

SECTION 12-64. Frequency and method of removal of waste. All household rubbish and garbage shall be removed from the curbside in front of each house in the city at least once each week during the year and at such other times as necessity may warrant. Each resident of a dwelling in the city shall place such household rubbish and garbage at the curbside in front of or near such dwelling in accordance with the other sections of this article and the Department of Public Works shall only be required to pick up such household rubbish and garbage as is placed on or near the curbside in front of or near each such dwelling. Such regular weekly removals and pick-ups by the Department of Public Works shall be carried out only on the days of Monday, Tuesday, Wednesday, Thursday and Friday of each week.

SECTION 2. This Ordinance shall take effect upon its passage.
