Dear Mayor Smiley,

The Department of Policy and Resiliency respectfully requests to amend award for the City of Providence Mentoring Project with MENTOR Rhode Island (MENTOR RI) for a total amount of \$820,000 (eight hundred twenty thousand dollars), for a total cap amount of \$995,000 in Fiscal Year 2024.

The amendment is necessary to reflect the total budget for the program: \$175,000 (one hundred seventy-five thousand dollars) for MENTOR RI to administer the program and provide technical assistance and \$820,000 (eight hundred twenty thousand dollars) for MENTOR RI to administer as pass-through grants to organizations operating mentoring programs in Providence.

This amendment is needed to allocate the full funding amount so that MENTOR RI may administer pass-through grants to community organizations that will deliver mentoring programs for Providence youth. These community organizations will receive technical assistance from MENTOR RI. The full award amount (\$995,000) has already been allocated to the City of Providence Mentoring Program, so there is no additional cost to the city. The Department of Policy and Resiliency did not disclose the full award amount throughout the RFP process in order to receive proposals for the cost to administer the City of Providence Mentoring Project. We shared with prospective bidders that all of the remaining award funds would be allocated to sub-grantees to deliver mentoring programs.




