## RESOLUTION OF THE PROVIDENCE WATER SUPPLY BOARD

WHEREAS, the legislature of the State of Rhode Island acknowledged the importance of protecting the public drinking water supplies in Scituate and enacted legislation to ensure the public's health and safety; and

WHEREAS, a land parcel in the Town of Scituate (Assessor's Plat 51, Lots 41, 67, and 68)) is located near the Scituate Reservoir; and

WHEREAS, the Board of the Providence Water hereby finds that the proposed development of this parcel would be detrimental to the preservation of the public's health and safety.

NOW, THEREFORE, BE IT RESOLVED,

1. That the Board of Directors voted to adopt a resolution to authorize the General Manager/Chief Engineer to complete the acquisition of A.P. 51, Lots 41, 67, and 68 (Hull Real Estate Trust) in Scituate and request the Providence Public Building Authority (PPBA) to process the acquisition.
2. This resolution shall take effect upon passage.
