No. 633 AN ORDINANCE AMENDING CHAPTER 760 OF 1953 ORDINANCES  
RELATIVE TO CLASSIFICATION PLAN.

Approved December 4, 1959

*Be it ordained by the City of Providence:*

SECTION 1. Chapter 760 of the Ordinances approved August 7, 1953 entitled "An Ordinance Establishing a Classification Plan for the City of Providence and repealing Chapter 1209, approved September 23, 1943" as amended, is hereby further amended by adding the following section:

Sec. 8. Wherever in the classification plan as established in Section 1 hereof, graduation from a standard high school is required as a minimum qualification for a described position, a high school equivalency diploma issued by the State of Rhode Island Department of Education shall be deemed the equivalent of a high school graduation diploma.

SEC. 2. Sec. 8 of Chapter 760 is renumbered to read Sec. 9.

SEC. 3. This Ordinance shall take effect upon its passage.



## CHAPTER 1307

No. 634 **AN ORDINANCE** IN AMENDMENT OF CHAPTER 27, SECTIONS 9 AND 10 OF THE REVISED ORDINANCES OF THE CITY OF PROVIDENCE, 1946, RELATIVE TO THE DEXTER DONATION TOWN MEETING.

Approved December 4, 1959

Be it ordained by the City of Providence:

SECTION 1: Section 9 of Chapter 27 of the Revised Ordinances of the City of Providence, 1946, entitled "Annual Town Meeting Relative to Dexter Donation" is hereby amended to read as follows:

"A meeting of the freemen of the City of Providence shall be holden in the City Council Chamber, or any other convenient place in City Hall, on the Fourth Thursday of October, 1960 at 2:00 o'clock p.m. Eastern Daylight Saving Time or Eastern Standard Time as may be in effect and biennially thereafter for the transaction of business relating to the property and estate devised to the Town of Providence by the last will and testament of Ebenezer Knight Dexter, denominated the Dexter Donation and other city and town property connected therewith." *DEW*

SEC. 2: Section 10 of said Chapter 27 entitled "Same-Notice" is hereby amended to read as follows:

"Notice shall be given by the City Clerk of the meeting on the Fourth Thursday of October, 1960 and of every biennial meetings thereafter which shall be published for and during one week next before said meetings, in one of the newspapers of said city." *DEW*

SEC. 3: This Ordinance shall take effect upon its passage.



## CHAPTER 1308

No. 635 **AN ORDINANCE** IN AMENDMENT OF SECTIONS 1010.1, 1010.2, 1010.3, 1010.31, 1010.32, 1010.33, 1010.34, 1010.35, 1010.36, 1010.4, 1010.5, OF CHAPTER 1079 OF THE ORDINANCES OF THE CITY OF PROVIDENCE, AS AMENDED, (Approved December 21, 1956) ENTITLED, "BUILDING ORDINANCES OF THE CITY OF PROVIDENCE" REQUIRING FLUES IN CERTAIN GAS FIRED EQUIPMENT.

Approved December 4, 1959

Be it ordained by the City of Providence:

Section 1. Section 1010.1 1010.2, 1010.3, 1010.31, 1010.32, 1010.33, 1010.34, 1010.35, 1010.36, 1010.4, 1010.5, of Chapter 1079 of the Ordinance of the City of Providence, as amended, known as the "Building Ordinance of the City of Providence" are hereby amended to read as follows:

Sec. 1010.1 FLUES REQUIRED. All gas fired equipment including boilers, furnaces, incinerators and all appliances which can be readily converted to the use of solid or liquid fuels and all other gas fired appliances shall be provided with chimneys, metal smoke stacks or effective flues as specified in this article.


*Rev.* Sec. 1010.2 EXCEPTION. Connections by flue or vent shall not be required for electric, gas and industrial appliances of such a size or character that the absence of such connection does not constitute a hazard to the fire safety of the building or its occupants.

Sec. 1010.3 VENTS REQUIRED. All gas fired equipment and gas appliances, except as provided in Section 1010.31 shall be vented to the outer air through approved vents of non-combustible, corrosion-resistive, material of adequate strength and heat insulating value as provided in Section 1011.0 of this article and in accordance with approved rules without in anyway limiting the foregoing. This equipment and gas appliances shall include:

- A. Central heating appliances including steam and hot water boilers, warm air furnaces, floor furnaces and vented recessed heaters,
- B. Unit heaters and duct furnaces,
- C. Gas-fired incinerators,
- D. Water heaters,
- E. Room heaters, this includes the space heating sections of bungalow gas ranges,
- F. Appliances equipped with gas conversion burners,
- G. Appliances which have draft hoods supplied by the manufacturer,
- H. Each of several appliances, not including domestic gas ranges, installed in the same room, with an aggregate input rating as great as thirty (30) B.T.U. per hour per cubic foot of room content.

Sec. 1010.31 EXCEPTIONS. Connections by flue or vent shall not be required for listed gas ranges, hot plates, laundry stoves, domestic clothes dryers, gas refrigerators and counter appliances of such size and character that the absence of such connection, in the opinion of the Director, does not constitute a hazard to the safety of the building or its occupants.

Sec. 1010.4 PROHIBITED USE. Water heaters shall not be installed in bathrooms, bedrooms, or habitable rooms that are normally kept closed.

Sec. 1010.5 SIZE OF VENTS. The cross sectional area of a flue or vent for a gas-fired appliance shall be at least one (1) square inch per seventy-five hundred (7500) hourly B.T.U. input, and the diameter shall not be less than three (3) inches in any case.

Sec. 2. This ordinance shall take effect upon its passage and all ordinances or parts of ordinances inconsistent herewith are hereby repealed.



Bonds in the aggregate principal amount of \$1,250,000 to be designated as "School Bonds--1959" and to be issued for the purchase of land for public school purposes and/or the construction, furnishing and equipping of public school buildings in the City of Providence, as authorized by Chapter 3639, P. L. of 1956.

Bonds in the aggregate principal amount of \$1,000,000 to be designated "Highway Reconstruction Bonds 1959" and to be issued for the purpose of constructing and reconstructing highways and/or for the purpose of acquiring land or easements in land in the City of Providence for highway purposes as authorized by Chapter 3679, P. L. of 1956.

Bonds in the aggregate principal amount of \$1,000,000 to be designated "Highway--Huntington Avenue Bonds" and to be issued for the purpose of reconstructing such highways in the City of Providence as the City Council may determine, including the acquisition of land for said purposes in cooperation with the State and Federal Governments as authorized by Chapter 3360 P. L. of 1954.

Bonds in the aggregate principal amount of \$1,000,000 to be designated "School Modernization Bonds, Series II" and to be issued for the modernizing of school buildings in the City of Providence as authorized by Chapter 3638, P. L. of 1956.

Bonds in the aggregate principal amount of \$300,000 to be designated "Sewage Treatment Bonds, Series II" and to be issued for the purpose of the repair, reconstruction and replacement of the Sewage Treatment Plant of the City of Providence as authorized by Chapter 3657 P. L. of 1956.

Total aggregate principal amount of bonds upon which bids were solicited and received as above specified is \$4,550,000.
