Whereas, Though these horrific events have affected all United States citizens, it is important that we carry on with the regular activities of our lives; terrorism cannot be allowed to break the spirit of our nation's people, nor the pillars upon which our country was built: life, liberty and the pursuit of happiness.

1) Condemns the terrorist attack on the United States and supports the President of the United States as he works with Congress and the national security team to defend against additional attacks, and find the perpetrators to bring them to justice.

2) Recommends that our community support relief efforts by residents donating blood at the nearest available blood donation center and/or through donations at the many charitable organizations that provide disaster support.

Bush, President of the United States, the Honorable Jack Reed and the Honorable Lincoln Chaffee, United States Senators, the Honorable Patrick Kennedy and the Honorable James Langevin, United States House of Representatives, the Honorable George Pataki, Governor of New York and the Honorable Rudolph Giuliani, Mayor of New York City.
