Highland Avenue.

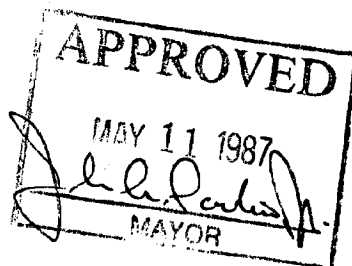
