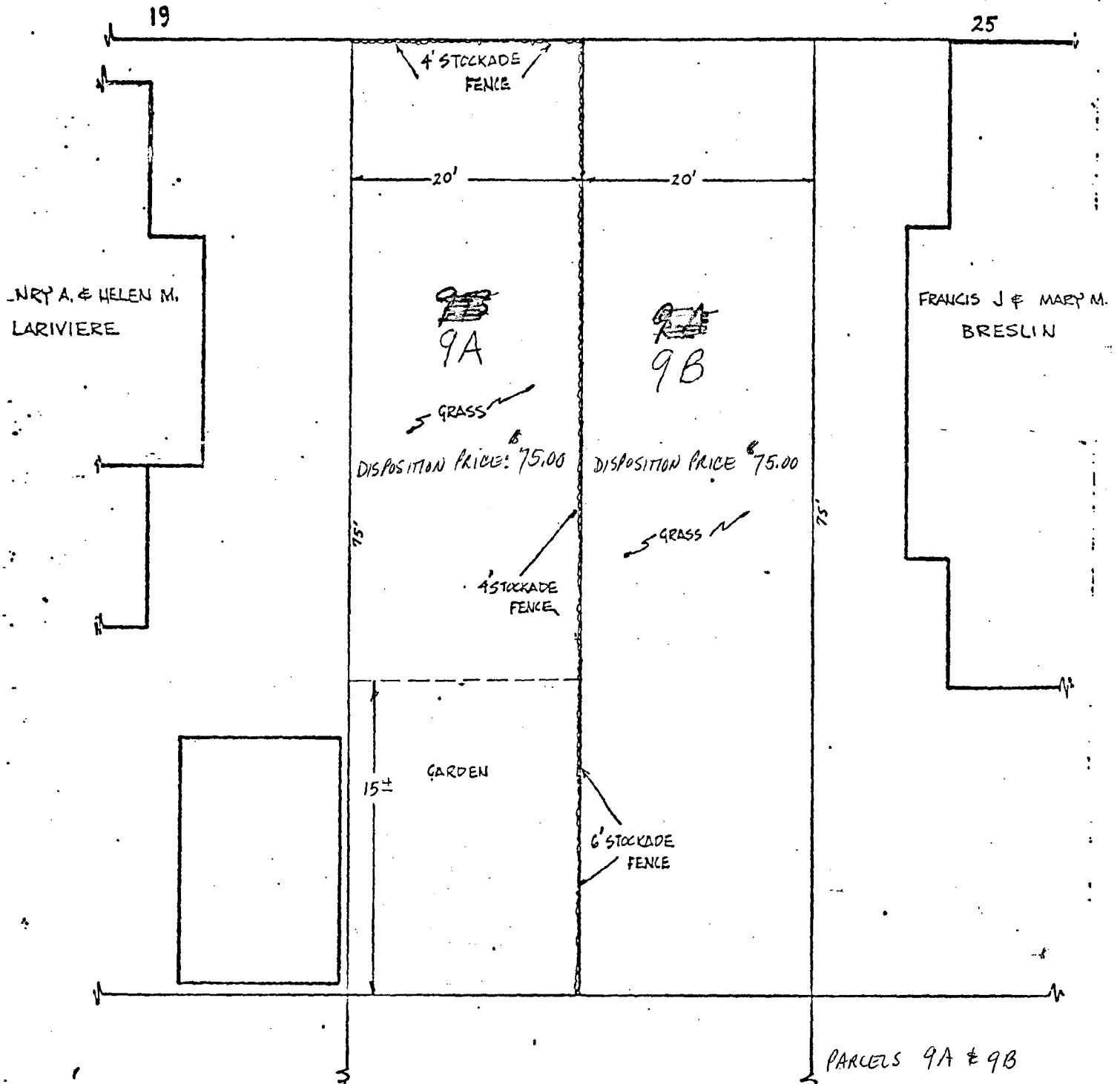


ASHMONT STREET
