After Jamaica, Jason accepted a job in Puerto Rico where he worked for the Puerto Rican Government in the area of economic development. In 1994 he joined Moran Shipping Agencies, where for the last 20 years he has worked in numerous positions including special projects manager, ISO quality manager, IT director, and in his current positions of executive vice president and chief information officer. 


