PERSONAL PRIVILEGE

COUNCILMAN GLAVIN requests the Floor to speak on a Point of Personal Privilege and states:

"Lately, there has been a number of incidents that have taken place in the City of Providence involving the Providence Police Department and Public Safety Personnel. This goes back to an issue we were talking about earlier, the need for a curriculum in the School Department against violence. Several major incidents have taken place.

Just last weekend there was a very serious incident that took place on the East Side, where over 300 individuals were involved, it was reported, and every police officer in the City of Providence was called to respond. Private Security People also joined in and it turned out to be a very dangerous situation. We had one police officer that was severely injured as well as numerous pieces of apparatus and equipment destroyed. Just today, an officer was struck by a motor vehicle and he had to respond to the situation with deadly force and a loss of life was incurred.

The main reason that I am speaking on this is that our City as well as many other Cities across the Country are handling the same type of violence and as in any organization, you will not have 100% perfect people working in the City as is the case across the World, but by and large overall, the majority of the people working in the City are good, honest and hard working and it showed me greatly to see what types of situations these people are dealing with in the Public Safety Departments; Police, Fire, Communications, Rescue Personnel and what they are up against. I've mentioned only two specific incidences, on a larger scale, not to mention all of the other individual, day to day cases. This is a very

difficult task for the people who choose a career in the Public Safety Field.

Despite our differences on an administrative level, the City Council, the Mayor in many cases have a difference of opinions with Municipal Workers. Whether it be regarding retirements or of a monetary issue, but that is part of the normal give and take between the two. However, that should in no way send the wrong message to the people in Public Safety and I would like them to know that we stand behind them, they have a very difficult job to do. Thank you Mr. President."
