COUNCIL PRESIDENT LOMBARDI Calls for Nominations for Two (2) Members of the Retirement Board of the Employees' Retirement System.


COUNCILMAN APONTE Moves to open up the elections for the Two (2) Vacancies on the Retirement Board of the Employees' Retirement System.
