CHAPTER 846

No. 265 AN ORDINANCE AMENDING CHAPTER 2 OF THE REVISED
ORDINANCES OF 1946 ENTITLED "ADMINISTRATION"

Approved May 7, 1954

Be it ordained by the City of Providence:

Section 1. That part of Section 88 of Chapter 2 of the Revised Ordinances of 1946 entitled "Administration," pertaining to the City Controller, which reads as follows:

"He may, under the advice and direction of the Finance Committee, destroy vouchers for payments that have been on file in his department ten years or more; copies of contracts and agreements on file in his department the terms of which have been completed ten years or more; and such letters and other miscellaneous papers, that have been on file in his department ten years or more, as said Finance Committee shall deem to be of no permanent value."

be and the same is hereby amended to read as follows:

"He may, under the advice and direction of the Finance Committee, destroy vouchers for payments that have been on file in his department six years or more; copies of contracts and agreements on file in his department the terms of which have been completed six years or more; and such letters and other miscellaneous papers, that have been on file in his department six years or more, as said Finance Committee shall deem to be of no permanent value."

Sec. 2. This Ordinance shall take effect upon its passage.
