




SUBJECT: Agenda Item # 14 - Resolution requesting the Traffic Engineer to cause the installation of a "Four-Way STOP" sign at the intersection of Moorland Avenue and River Avenue.

The DPW - Division of Traffic Engineering has investigated the request for a 4-way STOP at the intersection of Moorland Avenue and River Avenue and has the following to offer:

Out of all the possible warrants for stop sign applications, the only warrant that this request can be considered for review is the preventable accident history.

The accident history is as follows:

The average is 0.75 over an eight (8) year period. The requirement states that a crash problem may exist if there are five (5) or more reported accidents in a twelve (12) month period that are susceptible to correction by a multiway stop installation. Based on a review of the system warrant requirements, this intersection does not qualify for a four-way stop according to the Manual of Uniform Traffic Control Devices. The installation of a 4-way STOP at this intersection is not justified nor warranted.

As a corrective measure we did the following:

1. Renew the faded STOP sign traveling east on Moorland Avenue and upgraded it to a 30" STOP sign.
2. Renew the faded STOP sign traveling west on Moorland Avenue and upgraded it to a 30" STOP sign and replaced the twisted U-pole.
3. Installed supplemental left hand side STOP traveling west on Moorland Avenue.
4. Renew both "No Parking to Corner" signs on the westerly side of River Avenue.
