REPORT OF COMMITTEE ON PUBLIC WELFARE

Honorable Members:

Your Committee considered the following Resolution of the City Council No. 27, Approved February 12, 1976;

"RESOLVED, that the Committee on Public Welfare is requested to obtain from the Chief of Police, a report as to the Departments compliance with the Provisions of Section 23-23-12 of the General Laws of Rhode Island, 1956, as Amended, relative to Life Saving Buoys required in Police Vehicles."

Accordingly, it respectfully reports it studied the following:

(1.) Report of the Acting Chief of Police, dated March 12, 1976;

(2.) Memorandum to the Acting Chief of Police, dated March 17, 1976, requesting a more detailed report within the purview of the governing statute, being 23-23-12, of the General Laws of Rhode Island, 1956, as Amended, and

(3.) Communication from the Acting Chief of Police, dated March 26, 1976, responding to the prior Memorandum of March 17, 1976.

Your Committee respectfully reports that as a result of its study of the subject matter, it has ascertained that the Providence Police Department is not in complete compliance with the statute.

Accordingly, the Chief of the Police Department is hereby ordered to cause the equipping forthwith, of all marked and unmarked Police vehicles, which do not comply with the provisions of the State Law, and upon the completion of such compliance, that he report to the City Council concerning the same.

CONSIDERED BY: Councilman Philip F. Addison, Jr., Chairman

DISPOSITION: I submit the enclosure being a certified copy of the above subject.

23-23-12 of the General Laws of Rhode Island, 1956, as amended is as follows:

Lifesaving Buoy required in Police Vehicles.--All state and local police vehicles at all times shall maintain in the trunk area of said vehicles a lifesaving buoy and a minimum of one hundred fifty (150) feet of rope.

Councilman Addison desires a more detailed report within the purview of that statute namely, viz;

1. It appears from your report dated March 12, 1976, to the Committee on Public Welfare that thirty (30) marked cars are equipped only with life preservers and not lifesaving buoys and a minimum of 150 feet of rope; It further appears that the thirty (30) vehicles assigned to areas that do not have bodies of water and Superior Officers have no lifesaving equipment as required.

2. Do any of the City owned unmarked Police cars such as Task Force Assigned equipped with lifesaving equipment?

Will you kindly report in detail as above noted to the Committee on Public Welfare.

Dear Mr. Addison:

Regarding your request for more information concerning the compliance with Resolution of the City Council #27.

In reply to item #1 - all 30 cars are equipped with a ring-type, plastic foam, man overboard bouy, model #8408, manufactured by the Atlantic-Pacific Company of Brooklyn, N.Y. This bouy is approved for general use on motor boats of Class A, 1 or 2, not carrying passengers for hire and accepted as excess equipment on all other motorboats. The bouy carries a United States Coast Guard Approval #160.064/025/0. The bouy is a lightweight, easy throw type ring. Each car also is equipped with one hundred fifty feet of 1/4" nylon line, which is attached to the bouy.

The thirty equipped cars and the bodies of water they cover are as follows:


