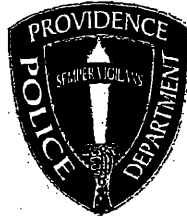

Final Contract Amount:	\$	62,500.00




