### AN ORDINANCE

IN AMENDMENT OF THE APPROPRIATION ORDINANCE CHAPTER 1976-38, APPROVED NOVEMBER 27, 1976, BY APPROPRIATING A SUM NOT TO EXCEED TWO THOUSAND, FIVE HUNDRED (\$2,500.00) DOLLARS TO PERMIT THE CITY TO CO-SPONSOR AND HOST THE NEW ENGLAND WHEELCHAIR GAMES ON MAY 20, 21, AND 22, 1977 IN THE CITY OF PROVIDENCE.

Approved April 15, 1977

*Be it ordained by the City of Providence:*

SECTION 1. Chapter 1976-38 of the Ordinance of the City of Providence, as approved November 27, 1976, entitled: "An Ordinance Making Appropriation of \$104,335,240.60 for the Support of City Government for the Fiscal Period beginning July 1, 1976, and ending June 30, 1977," is hereby amended by appropriating the sum of Two Thousand, Five Hundred (\$2,500.00) Dollars, for the New England Wheelchair Athletic Association, which will sponsor games on May 20, 21, and 22, 1977, in the City of Providence; said sum will help defray the expense of Wheelchair Games, which the City will co-sponsor and host.

SECTION 2. The said sum of Two Thousand, Five Hundred (\$2,500.00) Dollars, as thus added and appropriated, shall be obtained by authorizing the City Controller and City Treasurer to transfer Two Thousand, Five Hundred (\$2,500.00) Dollars from the Reserve Extraordinary Expenditures Account to the Receipt Account.

SECTION 3. The estimated Receipts from the Reserve for Extraordinary Expenditures Account are hereby increased by Two Thousand, Five Hundred (\$2,500.00) Dollars.

SECTION 4. This Ordinance shall take effect upon its passage by the City Council and its approval by the Mayor.
