RESOLUTION OF THE CITY COUNCIL

Approved December 23, 1977

RESOLVED, DECREED AND ORDERED:

That the following named right-of-way land shown as Cross-Hatched Area (A-B-C-D-E-A) on the accompanying plan entitled "Providence, Rhode Island, Department of Public Works - Engineering Office, City Property Section Plan No. 064011 Dated March 14, 1977",

viz:

Property bounded by Lot 142 A.P. 37, Service Road 6, and the proposed widening of Willow Street, having ceased to be useful to the public and the same is abandoned as right-of-way land and the damage to the abutters is appraised at nothing and so awarded, and it is further

ORDERED, That the Director of Public Works, be and he is hereby directed to cause a sign to be placed on the above-named land abandoned as aforesaid, having thereon the words "Not a Public Right-of-Way", and it is further

ORDERED, That after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper published in the County of Providence at least once each week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named land which has been abandoned, who is known to reside within this State.





On April 11, 1977, this department received copies of petitions for the abandonment of portions of the following:


Magner Place (entirety) and portions of McDonough Street and Marvin Street.


