WHEREAS, John F. Kiffney passed away on July 24, 1987 at the age of forty-five, and

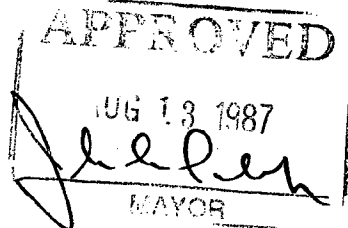
