Solomon, pursuant to Section 406 of the Providence Home Rule Charter of 1980 and Rule 3 of the Rules of the City Council, requested the City Clerk, in writing, to Call a Special Meeting of the City Council to be held on Monday, April 23, 2012 at 6:00 o'clock P.M., in the City Council Chamber, Third Floor, City Hall for the purpose of Enacting the following:

AN ORDINANCE IN AMENDMENT OF CHAPTER 2011-24, NO. 414, APPROVED JULY 18, 2011 OF THE ORDINANCES OF THE CITY OF PROVIDENCE, PROVIDING FOR THE ASSESSMENT AND COLLECTION OF 2012 TAXES IN A SUM NOT LESS THAN THREE HUNDRED SEVENTEEN MILLION ONE HUNDRED SIXTEEN THOUSAND ONE HUNDRED SEVENTY FIVE (\$317,116,175) DOLLARS AND NOT MORE THAN THREE HUNDRED THIRTY FIVE MILLION FOUR HUNDRED NINETY TWO THOUSAND FIVE HUNDRED EIGHTY FOUR (\$335,492,584) DOLLARS, BEING BASED ON A ONE HUNDRED PERCENT (100%) OF THE 2011-2012 FISCAL YEAR TAX COLLECTIONS, AND SETTING THE HOMESTEAD RATES FOR FISCAL YEAR 2013.




