No. 255 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1983-30 APPROVED JULY 10, 1983, BY TRANSFERRING THE SUM OF TWELVE THOUSAND DOLLARS (\$12,000.00) FROM THE PUBLIC WORKS HIGHWAY (1-005-08-142) REPAIR TO AUTO AND TRUCK ACCOUNT TO PUBLIC WORKS HIGHWAY (1-005-08-512) TRUCKS AND TRACTORS.

*Be it ordained by the City of Providence:*

SECTION 1. Chapter 1983-30 of the Ordinances of the City of Providence, as approved July 10, 1983, entitled: "An Ordinance making an Appropriation of One Hundred Sixty Nine Million, Seven Hundred Ninety Six Thousand, Two Hundred Forty Dollars and Ninety Six Cents (\$169,796,240.96) for the fiscal year ending June 30, 1984, as amended", is hereby further amended by transferring the sum of Twelve Thousand Dollars (\$12,000.00) from Public Works Highway (1-005-08-142) Repair to Auto and Truck Account to Public Works Highway (1-005-08-512) Trucks and Tractors.

SECTION 2. This Ordinance shall take effect upon its passage.
