

An Ordinance Amending Ordinance No. 409 of Chapter 2013-36, adopted September 19, 2013, Providing for the Assessment and Collection of 2013 taxes in a sum not less than Three Hundred Forty Million Eight Hundred and Fourteen Thousand Five Hundred Twenty Two Dollars (\$340,814,522) and not more than Three Hundred Fifty Two Million Seven Hundred and Forty Three Thousand and Thirty Dollars (\$352,743,030), being based on a One Hundred Percent (100%) of the 2014-2015 Fiscal Year Tax Collections, Amending Section 21-182 of the Code of Ordinances to reflect the Tax Classification Plan, Approved by the Rhode Island General Assembly, Amending Section 21-126 of the Code of Ordinances to raise the Personal Exemptions and setting the rates for Fiscal Year 2015.


