Resolution approving the accompanying plat entitled Dedication of Durfee Street (Widening), West Broadway Urban Renewal Project A2-1, Providence Redevelopment Agency, Stanley P. Blacher, Chairman, et al, Scale 1"=40.0", dedicating for highway purposes certain tracts of parcels of land shown as cross-hatched areas and designated by the letters A-B-C-D-E-A and F-G-H-J-K-F, and including as part of Durfee Street the area designated by the letters C-D-F-G-C (formerly part of Powhattan Street) on the accompanying plan under the provisions of Chapter 987 of the Public Laws of 1913, and thereafter declared a public highway to be repaired and maintained at the expense of the City of Providence.

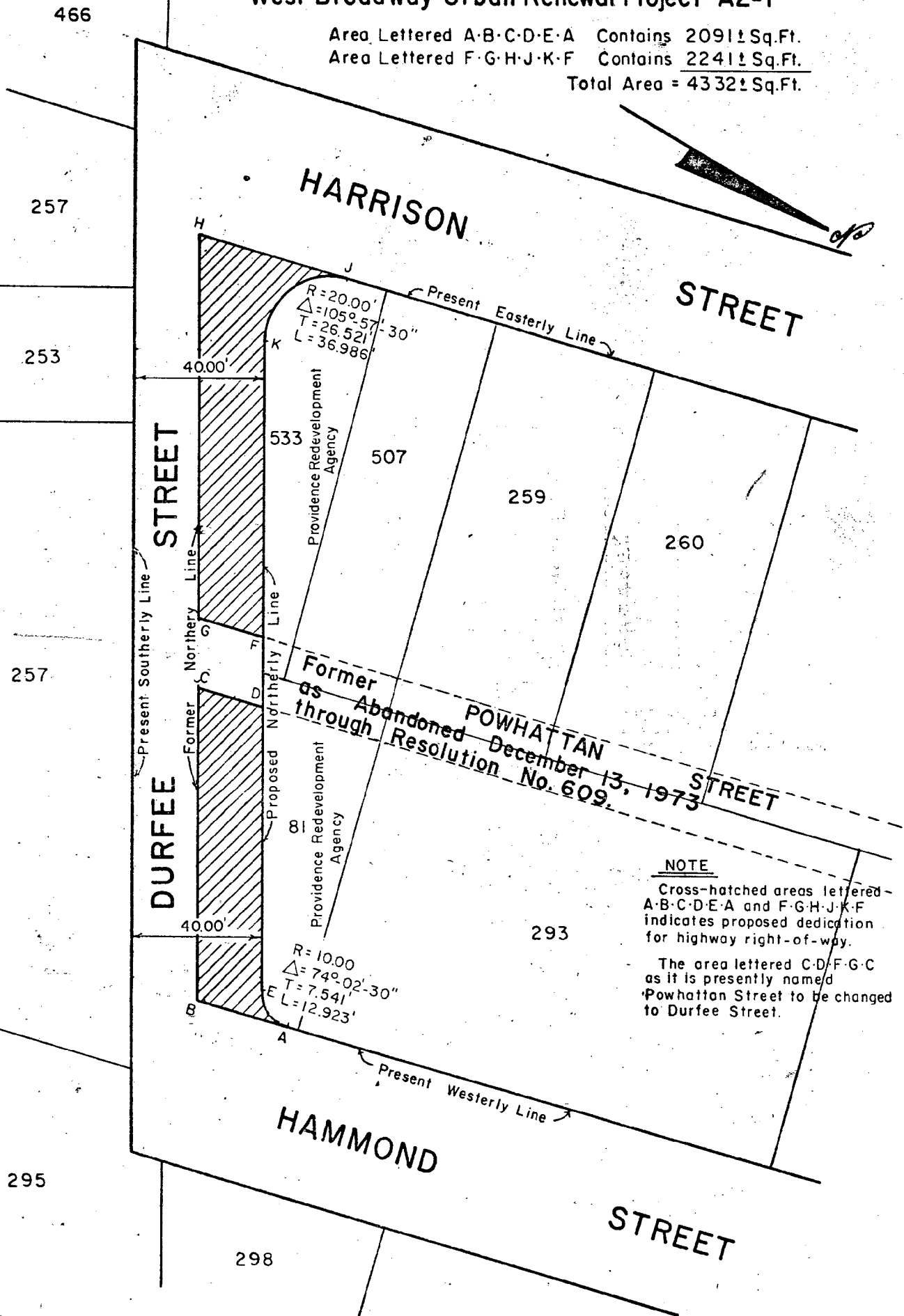
# DEDICATION OF DURFEE STREET (Widening)
