WHEREAS, The General Laws of the State of Rhode Island, Section 41-9-4, provides that before a gambling facility shall be established in any Town or City, the Town or City Council shall adopt a Resolution to pose to the qualified Electors of said Town or City and to the qualified Electors of the State at the next General Election the question:

"Shall a gambling facility and/or activity be established in said Town or City?"

NOW, THEREFORE, BE IT RESOLVED, That the Board of Canvassers and the Secretary of State submit to the qualified Electors of the City of Providence and the qualified Electors of the State of Rhode Island, respectively, at the next General Election to be called on November 5, 1996, the following question:

"Shall a gambling facility and/or activity be established in the City of Providence?" and

BE IT FURTHER RESOLVED, That the City Clerk is requested to forward certified copies of this Resolution to the Board of Canvassers and to the Secretary of State with a notice that the above question be placed on the ballot and be submitted to the said Electors pursuant to the General Laws of the State of Rhode Island, Section 41-9-4.


Dear Mr. Clerk:

Dear Mayor Cianci:

I just wanted to commend you on your veto of the Casino bill recently passed by City Council. Your forthright action places you in the forefront in taking the right stand for the people and communities of Providence.

There are vivid examples and ample evidence from Atlantic City to Las Vegas, from Biloxi to Reno, that casinos are a drain on the economy and inevitably take away more from communities than they add. This is especially true in urban areas such as Atlantic City, where over 80% of small businesses have gone under since the arrival of the slot machines and gaming tables. I believe the negative impact of a casino in Providence would be even more severe due to the fact that the economy in Rhode Island is already more devastated than that of other areas.

It was courageous of you to veto a measure popular enough to be approved by a large majority of the council but sometimes you have to be a statesman.

I commend you and I trust your action will be sustained by the council.
