WHEREAS, He is the father of three sons, John, Robert and Peter, with whom he takes great pride in,

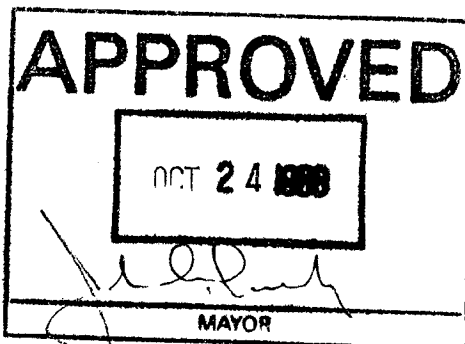
