Gentlemen:

The Petition to construct a main drain or common sewer, define the grade, establish a public highway, bring to the established or defined grade and set the curbing of Potter Drive from Hamlin to Thurston Street, Hamlin Street from its present easterly termination to the westerly Freeway Taking Line, Thurston Street from Stamford Avenue to the Freeway Taking Line, Netop Drive from Thurston Street southerly to its southerly termination, Spooner Street from Stamford Avenue to Netop Drive and Stamford Avenue from the southerly line of Spooner Street to the southerly line of Bissell Street is necessary to develop the subdivision of Roger Williams Park and thus prepare the area so that the houses in the area condemned by the State for the Huntington Expressway can be moved to their new location within said plat and connected to the necessary utilities with the necessary streets to service them.

These houses must be moved by May 1, 1964.
