ORDINANCE SECOND READING

The Following Ordinance was in City Council
September 18, 2003, Read and Passed the First Time
and is Returned for Passage the Second Time:

An Ordinance to Adopt the Payment in Lieu of Taxes Agreement by and between the City of Providence and Tockwotten Home.

Be it ordained by the City of Providence:

Whereas, Tockwotten Home is a 501(c)(3) non-profit corporation organized under the laws of Rhode Island, by legislative charter, in 1857 ("Tockwotten");

Whereas, Tockwotten is exempt from federal and state income taxation pursuant to I.R.C. 9501(c)(3) and property taxation by state legislative charter:

Whereas, Tockwotten owns properties located at 75 East Street in Providence, Rhode Island as further described as Plat 17, Lot 110, as recorded in the Land Evidence Records at City Hall, Providence Rhode Island (the "Property");

Whereas, in 1864 Tockwotten constructed a brick building upon the Property in order to provide quality care to its residents which building has been expanded over time, and is furnished with personal property for its operations (collectively the improvements and furnishings now existing or hereinafter built or furnished on and/or to the Property shall be referred to as the "Facilities");

Whereas, the City, since 1994 has issued annual tax assessments to Tockwotten regarding the Property and the Facilities;

Whereas, Tockwotten has annually appealed the assessment to the Board of Tax Assessment Review for the City of Providence and has filed Complaint in the Superior Court seeking a declaratory judgment asserting that any and all attempts by the City to levy or collect taxes on the Property or the Facilities are unlawful and a nullity; and

Whereas, the parties seek to settle and permanently resolve this dispute by establishing an annual PILOT Payment and agreeing that the

Property and Facilities are tax exempt.

Now, therefore, be it ordained by the City of Providence:

Section 1. The City Council of the City of Providence hereby adopts the Payment in Lieu of Taxes Agreement in the form substantially as attached hereto a Exhibit A (the "Agreement") as being in the best interest of the City and its citizens.

Section 2. The City Council agrees to support legislation in the form substantially attached to the Agreement as Exhibit "1", in order to finalize the intent of the Agreement.

Section 2. This Ordinance shall take effect immediately upon passage.

Resolution Ordering the abandonment of Bowditch Place.

Resolved, Decreed and Ordered: That the following-named street shown on a cross-hatched area on the accompanying map entitled "Prov. RI, DPW-Engineering Office, Street Line Section Plan No. 064701 dated December 13, 2001." VIZ: Bowditch Place, as described in Attachment "A" and shown as the cross-hatched areas on the accompanying plan and designated by the letters A-B-C-D-A, having ceased to be useful to the public, is proposed to be abandoned as a public highway. Said abandonment is specifically conditioned precedent upon the following:

1. The Petitioner agrees to tender the amount of One Dollar (\$1.00) in legal tender U.S. currency to the City of Providence.

2. The Petitioner agrees to maintain the abandoned portion for security and circulation around the new Providence Public Safety Complex.

3. The Petitioner shall comply with all conditions contained herein, including recording this Resolution, not later than sixty (60) days from its approval. Upon failure to so comply for any reason, the within resolution shall automatically become a nullity.

4. The Petitioner shall maintain easements which will permit retention of private sewer lines in their existing location, together with the right to inspect, maintain, operate and replace the same and with twenty-four hour access to said facilities.

5. The Petitioner shall maintain easements for the Providence Water Supply Board which will permit retention of its water services and a 6" cast iron main in their existing location together with the right to inspect, maintain, operate and replace the same and with twenty-four access to said facilities.

6. Such other conditions as the Mayor or the Law Department shall see fit to Impose.

Ordered, That the Traffic Engineer be and she is hereby directed to cause a sign to be placed on the above-named highway abandoned as aforesaid, having thereon the words, "Not a Public Highway," and it is further

Ordered, That after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper, published in the County of Providence at least once a week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named highway which has been abandoned, who is known to reside within the State.


