WHEREAS, Five (5) Members of the City Council, pursuant to Section 406 of the Providence Home Rule Charter of 1980, have respectfully requested that a Special Meeting of the City Council be held on the 1st Day of July, 1991 at 5:30 o'clock P.M. (E.D.T.) for the purpose of acting upon the following:

An Ordinance Providing for the Assessment and Collection of 1991 Taxes in a sum not Less than One Hundred Sixty-Nine Million Two Hundred Thousand Dollars (\$169,200,000) and not More than One Hundred Ninety Two Million Five Hundred Thousand Dollars (\$192,500,000) being based on One Hundred Percent (100%) of the 1991-1992 Fiscal Year Tax Collections.

An Ordinance Making an Appropriation of Two Hundred Sixty Three Million, One Hundred Fifty One Thousand, Eight Hundred Sixty- Four Dollars (\$263,151,864) for the Fiscal Year Ending June 30, 1992, as Amended.

An Ordinance Establishing the Classes of Positions, the Maximum Number of Employees and the Number of Employees in Certain Classes in the City Departments and Repealing Ordinance Chapter 1990-14, approved July 3, 1990, as Amended.

An Ordinance Establishing a Compensation Plan for the City of Providence and Repealing Ordinance Chapter 1990-13, approved July 3, 1990, as Amended.


